Urgent Announcement about Garbage and Recycling

The carts are coming! Garbage and recycling carts will be delivered to all households in the township between November 7th – 18th. The cart company will place your carts at the end of your driveway. **Plan to begin using your new carts with the November 18th recycle and garbage pick-up.**

The recycle carts will come with instructions on how to use them and how to place them at the end of your driveway. Follow the same placement instructions for your garbage carts.

The carts will be different colors and will be labeled to easily differentiate between garbage and recycling. The town board has decided to use money from the annual transmission line payment to pay for the carts.

When we start using them, both Inland (recycling) and Graichen (garbage) will have a grace period where they will assist our residents if carts are not placed or used correctly.

Once we are out of the grace period, your old garbage and recycling containers will not be emptied if you continue to use them. Also if your new carts are not placed correctly, they will not be emptied.

Both garbage and recycling carts will be property of the township. They stay with the property if you move.

Important Information about Community Housing Grants

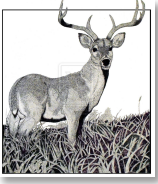

Dog Licensing and Free Rabies Clinic
